General fees and charges

CHEQUE TRANSACTIONS

Inward cheque dishonour \$15.00

Applies per cheque deposited to your account that is dishonoured.

Special cheque clearance \$15.00

Applies per cheque for which you have requested special clearance (fast clearance) when deposited.

Copy of a cheque[^] \$20.00

Applies per request for a copy of a deposited cheque.

PAYMENT SERVICES

Inward direct credit Free

An arrangement with a third party to electronically transfer funds to an RBoonline account (e.g. salary credit).

Direct debit dishonour \$35.00

Applies per unsuccessful direct debit attempt due to insufficient funds.

Real time electronic funds transfer \$30.00

Applies per transaction when funds are requested to be sent 'real time' or the same day to an account held with another Australian financial institution.

Trace on Real time electronic funds transfer* \$30.00

Applies per request to trace a real time electronic funds transfer.

International Funds Transfer (IFT) \$30.00

Applies per international funds transfer request (not available on non-verified accounts).

Trace on IFT* \$30.00

Applies per request to trace an IFT payment.

Note(s):

(1) The bank receiving (overseas bank) the electronic funds may also deduct a service fee. This fee will be deducted from the amount sent if incurred by the Bank.

(2) Additional charges may be incurred if an incorrect, incomplete or missing SWIFT Bank Identifier Code (BIC) or International Bank Account Number (IBAN) is provided.

(3) Please note the Bank may require additional information before we can process your IFT request. Please ensure this is promptly provided when requested by the Bank to ensure your request is not unnecessarily delayed.

Electronic trace[^] \$20.00

Applies when you have requested a trace on a BPAY[®] or Pay Anyone transaction or a transaction that has been sent electronically to another financial institution.

Electronic transaction recall \$15.00
per transaction recall

Applies per attempt to recall an electronic transaction. The fee is charged regardless if the transaction recall is successful.

* Fees may also be charged by destination financial institution

[^] If the voucher, cheque or payment search/trace reveals a Rural Bank error, the fee will be waived.

OTHER FEES AND CHARGES

Overdrawn account fee \$30.00

Applies where your account is overdrawn without prior arrangement with us. You will be charged this fee each day you perform a transaction on your account and your account remains overdrawn at the end of the day.

OTHER FEES AND CHARGES (CONT.)

Audit request \$30.00

Applies when an audit has been requested on an account.

Administration fee \$15.00
per quarter hour

Applies for the supply of information or other special services.

Dormant account \$20.00

An annual fee that applies to savings and transactional accounts that have not been activated by a customer initiated deposit or withdrawal for three years or more. This fee is waived when the customer has an active credit facility or a term deposit facility, or a combined balance of other savings and transactional accounts exceeding \$10,000 under the same customer number (excluding the dormant account).

Vasco One Touch security token \$25.00
(includes GST)

Key ring sized personal security token. Applies per security token ordered.

Vasco Professional security token \$99.00
(includes GST)

Small calculator sized multi user security token. Applies per security token ordered.

Transaction history print out \$5.00
per requested statement period

Payable when a print out on an account transaction history is requested.

Corporate cheque \$8.00

Applies per request for a corporate cheque.

Corporate cheque repurchase fee \$15.00

Applies when a corporate cheque is repurchased, as it is no longer required.

Corporate cheque stop \$15.00

Applicable per corporate cheque the Bank is requested to stop.

Bank cheque \$10.00

Applies per bank cheque. Bank cheques are issued through the Commonwealth Bank of Australia (CBA).

Bank cheque repurchase \$20.00

Applies when a bank cheque is repurchased, as it is no longer required.

Bank cheque stop \$20.00

Applies per request to stop a bank cheque.

Staff assisted transfer fee \$5.00

Applies per request to transfer money to an account held with another financial institution or a Rural Bank account in another name.
